It is again clarified that mandatory withholding income tax has been deducted @ $10 \%$ up to profit amount of Rs 500,000/- and for profit amount above Rs.500,000/- tax rates are $10 \%$ and $17.5 \%$ for filers and non-filers respectively as per active tax payer list provided by F.B.R at the time of payment/credit of profit to the respective customer account from gross amount of profit. In case of specific query for non-resident customers, rate of withholding income tax should be referred to Finance Group for advice.
